### **EXECUTIVE ORDER NO. 049**

**Series of 2020**

**AN ORDER ADJUSTING THE CURFEW HOURS AND LIQUOR BAN FROM 8:00 PM-5:00AM to 10:00PM-4:00AM IN THE MUNICIPALITY OF BAUANG, LA UNION.**

**WHEREAS**, the prevailing curfew and liquor ban in the municipality is from 8:00 PM to 5:00 AM as per E.O. No. 2020-030;

**WHEREAS**, the Sangguniang Bayan thru Resolution No. 264, Series of 2020 recommended to the Municipal Inter-Agency Task Force (MIATF) to adjust the existing curfew to 10:00 PM to 4:00 AM to accommodate the operation of restaurants;

**WHEREAS**, the Municipal IATF receiving recommendations from various groups and sectors recognizes the need to prepare the community for the impending opening of tourism and revival of businesses in the locality while maintaining peace and order, by slowly adjusting the window for people's movement and business window hours;

**WHEREAS**, guidelines for the re-opening of businesses, movement of people, health protocols and other necessary policies are being issued by various agencies including the provincial and municipal government of Bauang to guide all concerned;

**WHEREAS**, IATF Resolution No. 67, Series of 2020 dated August 31, 2020 placed the Province of La Union under Modified General Community Quarantine (MGCQ) until September 30, 2020, without prejudice to the declaration of localized Enhanced Community Quarantine in critical areas;

**WHEREAS**, the Municipal Peace and Order Council discussed and agreed with the recommendation to adjust the curfew hours and liquor ban to accommodate the request of the business community and to jumpstart preparations for the re-opening of tourism in the coming weeks or months;

**WHEREAS**, Section 16 or the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise



powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

**NOW THEREFORE, I, MENCHIE C. LOMBOY-DE GUZMAN, M.D.**, Municipal Mayor, by virtue of the powers vested in me by law, do hereby **ADJUST CURFEW HOURS AND LIQUOR BAN FROM 8:00PM-5:00AM TO 10:00PM-4:00 AM IN THE MUNICIPALITY OF BAUANG, LA UNION**, subject to existing and applicable national/local guidelines or subsequent policies and guidelines issued by the national government, and, this municipality.

This order takes effect immediately.
