EXECUTIVE ORDER NO. 049A

Series of 2020

AN ORDER REQUIRING MANDATORY WEARING OF FACE MASK AND FACE SHIELD, COUPLED WITH PROPER HAND DISINFECTION AND SOCIAL DISTANCING AT ALL TIMES, BY ALL PERSONS ENTERING PUBLIC BUILDINGS WITHIN THE MUNICIPALITY OF BAUANG, LA UNION, DURING THE TIME OF COVID-19 PANDEMIC.

WHEREAS, on April 29, 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-IED) approved the Omnibus Guidelines for Implementation of Community Quarantine in the Philippines (“Omnibus Guidelines”);

WHEREAS, the IATF amended the Omnibus Guidelines and provided among others, that “(2) the national government agencies and instrumentalities including GOCCs and LGUs shall adopt measures lawful and necessary to implement and enforce the minimum public health standards;

WHEREAS, the Municipal IATF recognizes the need to require wearing of prescribed face masks and face shields by all persons entering public buildings to reduce, if not, to prevent probable transmission and mitigate contamination from points of source among persons within enclosed areas such as air-conditioned offices;

WHEREAS, public buildings shall mean all buildings and enclosed areas where national and municipal offices are being housed or where government services are being provided to the public including the municipal public market and slaughterhouse;

WHEREAS, personnel from the Municipal Security Group and/or designated office personnel currently man entry and exit points of municipal buildings where minimum health protocols are being enforced and monitored;

WHEREAS, Section 10 of the Republic Act 11332 or the Mandatory Reporting of Notifiable Disease and Health Events of Public Health Concern provide penalties for violations;



WHEREAS, Section 16 or the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

NOW THEREFORE, I, MENCHIE C. LOMBOY-DE GUZMAN, M.D., Municipal Mayor, by virtue of the powers vested in me by law, do hereby order the mandatory wearing of face mask and face shield, coupled with proper hand disinfection and social distancing at all times, by all persons entering public buildings within the municipality of Bauang, La Union, during the time of COVID-19 pandemic, subject to existing and applicable national/local guidelines or subsequent policies and guidelines that may be issued by concerned authorities.

This order takes effect immediately.
