### EXECUTIVE ORDER NO. 051

**DECLARATION OF LOCKDOWN OF BAUANG NORTH CENTRAL SCHOOL (BNCS) LOCATED AT BARANGAY CENTRAL EAST, BAUANG, LA UNION, IDENTIFIED AS CRITICAL ZONE, DUE TO THE TOWN'S 19<sup>TH</sup> CONFIRMED CASE OF COVID-19 IN THE AREA.**

**WHEREAS**, the Municipal Mayor and members of the Municipal Task Force Against COVID-19 received information of the town's 19<sup>th</sup> confirmed case of COVID-19 leading to the identification of Bauang North Central School (BNCS) located at Barangay Central East, as a critical zone, and deemed it proper to impose LOCKDOWN thereat to prevent further community exposure;

**WHEREAS**, Patient No. BAU-19 is a 22-year old male police trainee who hails from San Carlos City and is one of the close contacts of the confirmed COVID-19 case from the training and recruitment event held at Bauang North Central School;

**WHEREAS**, Patient No. BAU-19 is asymptomatic and is currently isolated at ITRMC;

**WHEREAS**, the Municipal Health Office and the BHERT of Barangay Central East in cooperation with the PNP are currently monitoring the health conditions of those at the critical zone;

**WHEREAS**, the Municipal Contact Tracing Team (MCTT) and Barangay Contact Tracing Team (BCTT) of Barangay Central East are now currently tracking his contacts;

**WHEREAS**, the IATF issued the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

**WHEREAS**, Section 16 or the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;


