DECLARATION OF LOCKDOWN OF THE IDENTIFIED CRITICAL ZONE AT PUROK 3, BARANGAY TABERNA, BAUANG, LA UNION, DUE TO THE TOWN'S 21ST CONFIRMED CASE OF COVID-19 IN THE AREA.

WHEREAS, the Municipal Mayor and members of the Municipal Task Force Against COVID-19 received information of the town's 21ST confirmed case of COVID-19 leading to the identification of a critical zone at PUROK 3, Barangay TABERNA and deemed it proper to impose LOCKDOWN thereat to prevent further community exposure;

WHEREAS, Patient No. BAU-21 is a 36-year old male from Purok 3 of Barangay Taberna with no relevant travel history and no known exposure to a confirmed COVID-19 case;

WHEREAS, Patient No. BAU-21 was admitted at ITRMC last September 8, 2020 due to breathing difficulty where he was initially tested negative of the disease but another round of RT-PCR test conducted on him last September 18, showed today, that he is positive for COVID-19 and is now currently at the intensive care unit of ITRMC due to severe symptoms;

WHEREAS, the Municipal Health Office and the BHERT are currently monitoring the health conditions of patient's household members and immediate neighbours at the critical zone (compound) of Purok 3 of Barangay Taberna who will be subjected to RT-PCR Testing tomorrow September 21, 2020;

WHEREAS, the Municipal Contact Tracing Team (MCTT) and Barangay Contact Tracing Team (BCTT) of Barangay Taberna are now currently tracking his contacts;

WHEREAS, the IATF issued the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines;

WHEREAS, Section 16 or the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise

powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

NOW THEREFORE, I, MENCHIE C. LOMBOY-DE GUZMAN, M.D., Municipal Mayor, by virtue of the powers vested in me by law, do hereby declare the **identified Critical Zone at Purok 3, Barangay Taberna, Bauang, La Union**, under **14-DAY LOCKDOWN**, or until further notice.

This order takes effect at **12:01 AM** of **September 21, 2020**.
