### EXECUTIVE ORDER NO. 2020 – 010 B Series of 2020

#### EXPANSION OF THE NOVEL CORONA VIRUS (NCOV) TASK FORCE OF THE MUNICIPALITY OF BAUANG, LA UNION

**WHEREAS**, Section 16 or the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

**WHEREAS**, DILG Secretary Eduardo M. Año has directed all LGUs to be on a state of preparedness and take all pro-active steps to stop the spread of the dreaded Corona Virus, thus the creation of a Novel Corona Virus (NCOV) Task Force;

**WHEREAS**, the Municipality of Bauang in coordination with the DOH and the DILG has been implementing precautionary measures and monitoring arrival and movement of persons from foreign countries including the creation of the municipal COVID19 Task Force by virtue of Executive Order No. 2020-004;

**WHEREAS**, the World Health Organization (WHO) declared a World Health Emergency the outbreak of the Corona Virus;

**WHEREAS**, there is a need to cover other sectors that are most affected by the national health emergency and accommodate the designation of the OIC-MENRO last March 3, 2020;

**WHEREAS**, the Municipal Health Officer has been on leave from February 16 – March 11, 2020, prompting the Medical Officer II to be the alternative member;

**NOW, THEREFORE, I MENCHIE C. LOMBOY-DE GUZMAN**, Municipal Mayor of the Municipality of Bauang, La Union, by virtue of the powers vested in me by law do hereby order the following:



**Section 2. Functions:** The Task Force shall perform the following roles:

1. To implement DOH protocols and guidelines and extend full cooperation to the DOH and other government agencies to meet the world health emergency;
2. Shall ensure that local health authorities have the necessary equipment and protective gadgets such as masks, goggles, gowns, gloves, etc;
3. Cause the referral and transport of a Novel Corona Virus (NCOV) suspect to a DOH-designated Corona Virus-referral center or hospital, in coordination with DOH and police authorities;
4. Train health workers on NCOV prevention, containment, and control, in coordination with the DOH;
5. To conduct city and municipal-wide Corona Virus prevention, containment, and control information campaigns to educate the public;
6. Post public advisories about the Corona Virus as well as precautionary measures that the public can take such as maintaining proper hygiene and regular hand washing;
7. Perform such other roles as provided in the DILG Memorandum Circular No. 2020-018, dated January 31, 2020, Guides to Action against "Corona Virus".

**Section 3. EFFECTIVITY:** This Order shall take effect immediately.
