EXECUTIVE ORDER NO. 21A Series of 2020

AN ORDER IMPOSING EXTREME ENHANCED COMMUNITY QUARANTINE ("LOCKDOWN") OVER BARANGAY NAGREBCAN, THIS MUNICIPALITY.

WHEREAS, despite strengthening the Enhanced Community Quarantine by virtue of Executive Order No. 2020-18 issued last March 20, 2020, a 66 year old male from Barangay Nagrebcan, who has no travel history and no known contact with any COVID-19 positive individual turned out to be COVID-19 positive as per result that came in just today. He died last March 27 at Lorma Hospital and sent for cremation in Pampanga last March 28, 2020;

WHEREAS, the DILG issued a March 14, 2020-"Advisory on the Implementation of Community Quarantine", by virtue of DILG Executive Secretary Memo, on the stringent social distancing measures and further guidelines for the management of the coronavirus disease in consonance with the declaration of President Rodrigo Roa Duterte of Enhanced Community Quarantine over the entire Luzon;

WHEREAS, President Rodrigo Roa Duterte ordered all local government units down to the barangays to actively and strictly impose directives from the national government regarding the restriction of movement/lockdown;

WHEREAS, Section 16 or the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

NOW THEREFORE, I, **MENCHIE C. LOMBOY-DE GUZMAN, M.D.**, Municipal Mayor, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. There is hereby imposed an "Extreme Enhanced Community Quarantine ("lockdown") over Barangay Nagrebcan, this municipality, beginning 12 midnight tonight until 14 April 2020, unless earlier lifted or extended as circumstances may warrant and upon the recommendation of the Municipal Health Officer, this municipality.

SECTION 2. Contact tracing shall be continuously and strictly undertaken in accordance with DOH and DILG protocols.

SECTION 3. Strict home quarantine shall be imposed on all households. Strictly no loitering.


SECTION 4. Barangay Peace-keeping forces in cooperation with the PNP are hereby directed to undertake all necessary measures to ensure peace and order at barangay Nagrebcan, as may be necessary, including implementation of strict quarantine protocols at Barangay Control Points and arrest of quarantine violators.

SECTION 5. Barangay Officials, BHERT and concerned municipal offices like the MSWDO, MDRRMO and MHO, are enjoined to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate medical, relief and other response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19 transmission in the barangay.

SECTION 6. Neighbouring barangays are highly enjoined to take precautionary measures and strengthen their respective Barangay Control Points (BCPs).

SECTION 7. The IATF and ICS are hereby directed to closely monitor issues and assist in the implementation of this order.
