EXECUTIVE ORDER NO. 22
Series of 2020

AN ORDER IMPOSING EXTREME ENHANCED COMMUNITY QUARANTINE ("LOCKDOWN") IN THE MUNICIPALITY OF BAUANG, LA UNION.

WHEREAS, the municipality has strictly implemented enhanced community quarantine procedures as per national guidelines and LGU EO No. 2020-18, from suspension of classes and government work, restricted business activities to essential businesses only, suspended mass public transportation, strictly monitored PUMs and PUIs among others, in order to prevent and protect the municipality from the threat of COVID-19;

WHEREAS, to date, there are two (2) positive cases in separate barangays: Case No. 1 is a 66-year old male from barangay Nagrebcan who died while being confined at Lorma Hospital on March 27 while the second is a 56-year old male from barangay Central West who is currently confined at Bethany Hospital. Both have no travel history and no known contact with any COVID-19 positive individual;

WHEREAS, the DILG issued a March 14, 2020 "Advisory on the Implementation of Community Quarantine", by virtue of DILG Executive Secretary Memo, on the stringent social distancing measures and further guidelines for the management of the coronavirus disease in consonance with the declaration of President Rodrigo Roa Duterte of Enhanced Community Quarantine over the entire Luzon;

WHEREAS, President Rodrigo Roa Duterte ordered all local government units down to the barangays to actively and strictly impose directives from the national government regarding the restriction of movement/lockdown;

WHEREAS, Section 16 of the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

NOW THEREFORE, I, MENCHIE C. LOMBOY-DE GUZMAN, M.D., Municipal Mayor, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. There is hereby imposed an "Extreme Enhanced Community Quarantine ("lockdown") in the municipality of Bauang, La Union, beginning 12

midnight tonight until 30 April 2020, unless earlier lifted or extended as circumstances may warrant.

SECTION 2. Barangay Central West is hereby placed under "Extreme Enhanced Community Quarantine ("lockdown"), beginning 12 midnight tonight until 15 April 2020, unless extended or earlier lifted upon the recommendations of the Municipal Health Officer to be properly coordinated thru the concerned barangay captain.

Provisions and guidelines on barangay enhanced community quarantine (EECQ) or "lockdown" provided under EO No. 2020-21 shall apply to Barangay Central West.

SECTION 3. Contact tracing shall be continuously and strictly undertaken in accordance with DOH and DILG protocols.

SECTION 4. All municipal offices and Barangay Officials are enjoined to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake critical, urgent, and appropriate medical, relief and other response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19 transmission in the municipality. Offices below but not limited to the following:

BHERT	monitor PUIs and PUMS; act as support arm for households in barangays with "lockdown" status
BARANGAY OFFICIALS	Fully implement quarantine protocols and look after the welfare of all especially the poorest of the poor
BFATs	Enforce quarantine guidelines, man Barangay Control Checkpoints (BCCPs) and apprehend violators in cooperation with the PNP
MSWDO	Provide relief goods and other social assistance to constituents
AGRICULTURE OFFICE	Ensure availability of food supply
MUN. HEALTH OFFICE	Medical relief/assistance; enforcement of DOH protocols
MDRMO	Other emergency response measures
REGULATORY OFFICES	Ease down regulations as far as practicable in cooperation with MHO and PNP
MUN. FINANCE OFFICES	Provide necessary funds; facilitate financial documents
MUN. SUPPORT OFFICES	Provide required personnel, logistics and supplies needed
LEGISLATIVE OFFICE	Provide necessary legislations
ICS / COMMAND CENTER	Take charge of day to day management of the EECQ
IATF	Monitor/recommend implementation of quarantine guidelines and related concerns
OTHER OFFICES	Support the implementation of EECQ as required

SECTION 5. All law enforcement and peace-keeping offices and personnel led by the PNP are hereby directed to undertake all necessary measures to ensure peace and order within the municipality, as may be necessary, including implementation of

strict quarantine protocols at Municipal Checkpoints, Barangay Control Points and arrest of quarantine violators.

SECTION 6. All mass transportation remain suspended to include tricycles, padyak, colong-colong, and the like subject to existing regulations (i.e. travel pass/permits) if used for essential trips.

SECTION 7. All concerned offices are hereby directed to closely monitor and address issues, provide clarifications and cooperate with each other in the implementation of this order.
