EXECUTIVE ORDER NO. 16A
Series of 2020

ACTIVATING THE INCIDENT COMMAND SYSTEM PURSUANT TO EXECUTIVE ORDER NO. 2019-145 AS ON-SCENE EMERGENCY RESPONSE FOR THE CURRENT WIDESPREAD CORONA VIRUS 2019 PANDEMIC.

WHEREAS, the World Health Organization (WHO) declared on 11 March 2020 that the Covid-19 outbreak is now a global pandemic;

WHEREAS, President Rodrigo Roa Duterte declared a National Health Emergency on March 9, 2020 by virtue of P.D. 922 dated March 8, 2020 to facilitate implementation of the relevant provisions of RA No. 11332 to address the COVID-19 threat, and, capacitate LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, mitigate its effects and impact to the community, and prevent serious disruption of the function of the government and the community;

WHEREAS, On March 16, 2020, President Rodrigo Roa Duterte placed the entire country under a state of calamity for six (6) months and the entire Luzon under Enhanced Community Quarantine by virtue of PD No. 929, and ordered all government agencies and local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail or eliminate the COVID-19 threat;

WHEREAS, the Municipal Government of Bauang in consonance with CSC Announcement No. 12, S. 2020, suspended regular office work in all its departments and adopted a work-from-home scheme from March 16-April 14, 2020, to prevent spread of COVID-19 in the different offices, except those whose services cannot be dispersed with like health, security, traffic, social service and other vital and critical units;

WHEREAS, there is a need to establish an on-scene emergency response to take charge of the day to day activities in the implementation of guidelines on enhanced community quarantine in the municipality.

WHEREAS, Executive Order No. 2019-145 provided for the adoption of the Incident Command System (ICS), this municipality;

WHEREAS, Section 16 of the General Welfare Clause of the Local Government Code of 1991 gives local government units the authority to exercise powers necessary for efficient and effective governance and those which are essential to the promotion of the general welfare;

NOW THEREFORE, I, **MENCHIE C. LOMBOY-DE GUZMAN, M.D.**, Municipal Mayor, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. The Incident Command System is hereby activated pursuant to Executive Order No. 2019-145 adopting the Incident Command System as an on-scene emergency response for the current widespread corona virus 2019 pandemic.
