#### TERMS AND CONDITIONS:

1. The sale shall be on "AS IS, WHERE IS" basis which shall be awarded to the highest bidder;
2. The envelope containing the above listed items should be sealed and signed by the bidder and properly labeled containing the name of the bidder and the item to be bid with bid bonds equivalent to 10% of the bid price;
3. Bids shall be submitted on or before the time scheduled for the opening of bids. A bidder may be allowed to withdraw a bid tender before the time of opening of bids. The bid/s shall be returned unopened. Changes shall not be allowed on the bid forms after the deadline for the submission of bids;
4. Bid bonds of the non-winning bidders shall be returned immediately after the announcement of the winning bidder while bid bond of the winning bidder shall be deposited to the treasury office after the bidding proper. Bid bond of the winning bidder

shall be considered partial payment. Full payment shall be made within five (5) working days from the date of the bidding and immediately remove/pull out the properties;

The municipality reserves the right to reject any or all bids, to waive any formality therein or to accept such bids as may be considered most advantageous to the municipality.
